**ORDER GRANTING INTERVENTION TO CITIZENS' UTILITY RATEPAYER
BOARD**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records and being fully advised in the premises, the Commission finds and concludes as follows:

1. On March 30, 2012, Kansas City Power & Light (KCP&L) filed its Application for Approval of Its 2012 Energy Efficiency Rider.
2. Citizens' Utility Ratepayer Board (CURB) petitioned the Commission on April 4, 2012, to permit it to intervene in this proceeding.
3. CURB represents the interests of residential and small commercial ratepayers in Kansas. CURB contends that these customers may be adversely affected by this proceeding, and, without CURB's intervention, their interests are not adequately protected.
4. The Commission has broad discretion to grant a petition for intervention if it is in the interest of justice, if the intervention will not impair the orderly and prompt conduct of the proceedings, and if the party has stated facts demonstrating its legal rights, duties, privileges, immunities, or other legal interests may be substantially affected by the proceeding. K.S.A. 2011 Supp. 77-521; K.A.R. 82-1-225. Furthermore, at any time during a proceeding, the Commission

may impose limitations on an intervenor's participation. K.S.A. 2011 Supp. 77-521(c).

5. The Commission finds and concludes that CURB has met the requirements of K.S.A. 2011 Supp. 77-521 and K.A.R. 82-1-225 and should be granted intervention.
