ORDER APPROVING APPLICATION

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and determination. Having examined its files and records, the Commission finds and concludes:

- 1. On July 23, 2025, Evergy Kansas Central, Inc. & Evergy Kansas South, Inc. (together "Evergy Kansas Central") and Evergy Metro, Inc. ("Evergy Kansas Metro") filed a joint application (collectively, "Evergy") in the above-captioned docket requesting modifications to their Large Economic Development Rider ("LEDR") tariffs to conform with SB 98.
- 2. On July 31, 2025, the Commission issued an order granting the petition of the Citizens' Utility Ratepayer Board ("CURB") to intervene and its motion for a protective and discovery order in the docket.
- 3. On August 7, 2025, Commission Staff ("Staff") filed its Report and Recommendation ("Staff's R&R") regarding Evergy's application in the docket.² Staff's R&R analysis verified that Evergy's proposed changes to its LEDR tariffs conform with SB 98 and

recommended the Commission approve Evergy's application with some modifications.³ The Commission adopts Staff's R&R as additional findings and incorporated by reference herein.

4. The Commission holds full power, authority and jurisdiction to supervise and control Evergy as an electric public utility pursuant to K.S.A. 66-101. The Commission holds jurisdiction over Evergy's rates and terms of service under K.S.A. 66-101b. All tariff revisions requested by Evergy pertaining to jurisdictional service must be approved by the Commission pursuant to K.S.A. 66-117.

5. Counsel for CURB represented that it had the opportunity to review Staff's R&R and that it has no objections to Staff's recommendations.⁴

6. The Commission finds Evergy's application conforms to the language of SB 98.

7. The Commission concludes Evergy's application with Staff's recommended modification is just and reasonable and should be approved.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Evergy's application is hereby approved subject to Evergy making the modifications recommended by Staff.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁵
