**ANNUAL UPDATE OF CUSTOMER LIST**

Pursuant to the Order Granting Application issued by the Kansas Corporation Commission (Commission) in this docket on October 18, 2019 (Order), American Energies Gas Service, LLC (AEGS) files its annual update of its active customer list with the Commission.

1. AEGS is a natural gas public utility company existing under and by virtue of the laws of the State of Kansas.

2. AEGS is granted a customer-specific certificate of convenience and authority from the Commission to serve customers located in portions of Harvey, Marion and McPherson Counties in the State of Kansas.

3. Pursuant to the Commission's Order, AEGS is required to file an annual update of its active customer list with the Commission before March 1.


4. Attached to this filing as **Exhibit A** and incorporated herein by reference is a list of AEGS's existing customers as of January 5, 2023. The list includes the address at which the customer receives service. The customers highlighted in yellow in **Exhibit A** are new customers who have received service beginning in 2022 and who are receiving service at locations where AEGS had previously provided service to that location, but to a different customer.

5. Attached to this filing as **Exhibit B** and incorporated herein by reference is a list of

customers who no longer are receiving service from AEGS because either (i) those customers have moved out of the location (in those cases AEGS still has facilities at those locations and is capable of providing natural gas to those locations in the event a new customer would move into those locations); or (ii) AEGS was no longer capable of providing natural gas service to those customers, converted those customers to propane service, and received permission to abandon service to those customers in Docket No. 20-AEGG-097-CCS.

6. AEGS has designated the customer information contained in **Exhibit A** and **Exhibit B** as **CONFIDENTIAL**.

WHEREFORE, pursuant to the Order issued in the above-captioned docket, AEGS files its updated list of customers.




