In compliance with Order No. 7 and Order No. 8 issued by the State Corporation Commission of the State of Kansas (“Commission”) on April 19, 2000, and May 25, 2020, respectively, Kansas Gas Service, a division of ONE Gas, Inc. (“Kansas Gas Service” or “Company”), hereby files its annual report. Kansas Gas Service reports as follows:

I. DESCRIPTION OF KANSAS GAS SERVICE

1. Kansas Gas Service is a natural gas public utility operating in the state of Kansas pursuant to certificates of convenience and necessity issued by the Commission. Kansas Gas Service’s principal place of business within the state of Kansas is located at: 7421 West 129th Street, Overland Park, Kansas 66213.

II. COMPLIANCE FILING

2. Order No. 7 and Order No. 8 require Kansas Gas Service to annually report customers taking service at discounted rates pursuant to the Company’s Commission-authorized flexible tariff.¹ Attached, please find Kansas Gas Service’s annual report (“Report”).

3. Paragraph 10 of Order No. 8 authorizes the Report to be filed confidentially. Pursuant to K.S.A. 66-1220a and K.A.R. 82-1-221a, Kansas Gas Service designates the Report confidential. The Report contains confidential commercial information (i.e., customer-specific,
