This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On May 5, 2017, Commission Conservation Staff (Staff) issued a Notice of Denial

of License Renewal Application to L & G Petroleum Operating, LLC (Operator).<sup>1</sup> Staff stated the Operator's license was denied on the basis of Staff's assertion that the Operator's Application did not meet the requirements of K.S.A. 55-155.<sup>2</sup>

2. On May 30, 2017, Operator timely filed its request for hearing.

3. On April 19, 2018, Staff filed a Motion to Close Docket, noting that "Staff has

approved Operator's application and has issued Operator's license."<sup>3</sup>

4. Given Staff's issuance of the Operator's license, the Commission finds that granting Staff's Motion is in the public interest.

## THEREFORE, THE COMMISSION ORDERS:

A. Staff's Motion to Close the Docket is granted.
