WITHDRAWAL OF MOTION

Staff of the Kansas Corporation Commission (Staff and Commission, respectively) withdraws its motion requesting the designation of a presiding officer and scheduling a prehearing conference in anticipation of a hearing regarding the captioned matter. In support of its withdrawal, Staff states the following:

1. In November 2024, Staff received approximately 55 Request for Change of Operator (T-1) forms requesting to transfer 421 wells from Daylight Petroleum, LLC (Daylight) to Bluejacket Operating, LLC (Bluejacket). The T-1 forms did not include eleven wells located on the Johnson lease and the Olnhausen Farms #6 well located in Section 16, Township 30 South, Range 16 East, Wilson County, Kansas.

2. On January 21, 2025, Staff filed a motion requesting the designation of a presiding officer and the scheduling of a prehearing conference. Staff's motion was based upon its concern of the financial burden that could be left to the State if the T-1 forms were processed and Daylight was able to leave its plugging obligations behind.

3. While Staff's concerns are still present, Staff has determined to pursue an alternative course of action which resolves the captioned matter. Staff intends to process the T-1 forms between Daylight and Bluejacket once they are resubmitted, as long as they meet the requirements of K.A.R. 82-3-136. Further, Staff will not transfer injection authority for any currently permitted injection wells if Staff finds an abandoned well or any of the wells remaining under Daylight's license within a quarter mile area of review pursuant to K.A.R. 82-3-410.

WHEREFORE, Staff respectfully withdraws its motion in the above captioned matter and intends to process any T-1 forms that are resubmitted between Daylight and Bluejacket as described above.
