**STAFF’S STATUS UPDATE**

COMES NOW, the Staff of the Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively), files its Status Update relevant to Staff’s projected Report and Recommendation (R&R) date in this docket. In support of its Status Update, Staff states as follows:

1. On April 2, 2015, Anadarko Natural Gas Company, LLC (“ANGC”) filed an Application with the Commission seeking approval of four customer specific contracts for the sale and/or transportation of natural gas on the Hugoton Residue Distribution System.<sup>1</sup>
2. As noted in the Commission’s Suspension Order issued April 16, 2015, Staff aimed to complete its R&R by June 1, 2015.
3. Due to Staff’s busy schedule and the press of other Commission business, Staff has determined that it will be unable to complete its R&R by the original target date.
4. Staff will continue to proceed with their investigation with all due haste as well as engage in dialog with any interested parties to ensure the timely resolution of this matter.
5. Staff continues to recognize the need for efficient use of Commission resources, and will thus strive to complete its Report and Recommendation by August 31, 2015.


