**ORDER NUNC PRO TUNC CORRECTING
ORDER CONSOLIDATING DOCKETS**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined the files, the Commission finds and concludes that:

1. An Order Consolidating Dockets was issued in this docket on March 19, 2015.
2. Docket No. 15-WSEE-211-COM and Docket No. 15-KCPE-265-COM were consolidated into one proceeding as a result of the Order.
3. On March 31, 2015, the Staff of the Commission filed an Errata in this proceeding that identified a typographical error for one of the Complainant's names.
4. The caption heading and paragraph 2 of the Order Consolidating Dockets contained the incorrect spelling. The Commission corrects these errors by changing references in the caption heading and paragraph 2 of the Order Consolidating Dockets from "Denen" to "Denese."

IT IS THEREFORE, BY THE COMMISSION ORDERED:

- A. By this Nunc Pro Tunc Order, the Commission corrects its Order Consolidating Dockets.

B. The parties have 15 days, plus three days if service of this Order is by mail, to petition the Commission for reconsideration.¹

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
