- 1. On November 27, 2017, Operator filed an Application for Injection Well (Application) along with an Affidavit of Publication from the Ottawa Herald requesting a permit to authorize the enhanced recovery of oil by injection of saltwater into the Squirrel formation at the Blunk Lease, wells I-10 and I-11, located in Franklin County, Kansas.¹
- 2. On March 2, 2018, a letter was filed in the docket by Phil Frick, President of Frick Energy Services, LLC, on behalf of JTC Oil, Inc., stating JTC wished to withdraw the pending applications and requested the upcoming hearing be cancelled.

THEREFORE, THE COMMISSION ORDERS:

A. Applicant's request to withdraw the Applications is granted. The scheduled Prehearing Conference is cancelled. This Docket shall be closed.
