AMENDED APPLICATION

Comes Now Applicant, Cholla Production, LLC ("Cholla"), and hereby amends its Application for an order, pursuant to K.A.R. 82-3-103a, permitting the drilling of a horizontal well, to be known as the Kohl 1-33H. In support of this Amended Application, Cholla states as follows:

- 1. Except as set forth herein, all of the information contained in the Application filed by Cholla in this docket remains unchanged.
- Cholla has decided to move the surface location for two reasons: to move the location out of
 a channel onto a topographically flat area, thus providing a more stable surface for
 operations, and to better accommodate the steering of the well to avoid pre-existing plugged
 wellbores.
- 3. The previously approved surface location was 75' FSL and 2260' FWL. The new proposed surface location is 150' FSL and 1785' FWL. Attached hereto as Exhibit A is a plat showing the property with the previously approved and the proposed amended surface locations.
- 4. Applicant will cause a copy of this Amended Application to be mailed or delivered to each person entitled to receipt of the same, and will publish notice of this Amended Application in at least one issue of the official county newspaper of Trego County, the *Western Kansas World*, and at least one issue of *The Wichita Eagle* newspaper, in accordance with the notice requirements of K.A.R. 82-3-135a.

WHEREFORE, Applicant prays that this Amended Application be granted administratively, without a hearing, and that the Commission issue its order authorizing Cholla to conduct the horizontal drilling operations as described in the Application and this Amended Application, but if timely and proper protest is received, that the Commission set this matter for hearing and upon

such hearing issue the requested order, and that the Commission grant to the Applicant such other and further relief as the Commission may deem just and proper.
