This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

On February 13, 2020, the Commission issued a Penalty Order against Operator, 1. finding one violation of K.A.R. 82-3-120 because unplugged wells remained on Operator's expired license.¹ On April 6, 2020, Operator timely requested a hearing.²

On May 21, 2020, a prehearing conference was held.³ 2.

At the prehearing conference, Operator and Commission Staff agreed to set a status 3. conference for June 11, 2020, to allow for discussion of the possibility of resolution of this matter absent the need for a procedural schedule, and to provide Operator an opportunity to obtain counsel if necessary.
