- 1. On April 05, 2018, the Commission issued a Penalty Order against the Operator in the captioned docket.
- 2. On April 25, 2018, the Operator filed a timely appeal. On May 10, 2018, the Commission issued an order setting this matter for a July 12, 2018, prehearing conference.
- 3. Counsel for Staff appeared at the pre-hearing conference on July 12, 2018, but the Operator failed to appear. Staff made a verbal Motion for Default at the prehearing conference.

 The Prehearing Officer requested the Motion be submitted in writing.
- 4. Pursuant to K.S.A. 77-520(a), "[i]f a party fails to attend or participate in a prehearing conference, hearing or other stage of an adjudicative proceeding, the presiding officer may serve upon all parties written notice of a proposed default order, including a statement of the grounds."
- 5. Staff believes Operator was properly noticed and afforded an opportunity to attend and participate in the July 12, 2018, prehearing conference, but failed to do so. Therefore, Staff requests that a default order be issued against Operator.

WHEREFORE, for the reasons set forth above, Staff respectfully requests the Commission issue a default order against Operator for failure to appear and participate, and for any further relief as the Commission deems just and proper.
