ORDER SETTING PROCEDURAL SCHEDULE AND DESIGNATING PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On April 26, 2019, Western Cooperative Electric Association, Inc. (Western) filed an Application requesting approval to update its Local Access Delivery Service (LADS) tariff.¹
- 2. On May 2, 2019, the Kansas Power Pool (KPP) petitioned to intervene, and on May 14, 2019, KPP was granted intervention.²
- 3. On May 14, 2019, Susan B. Cunningham entered her appearance on behalf of Kansas Electric Power Cooperative, Inc. (KEPCo).
- 4. On May 16, 2019, Western, KEPCo, KPP, and Commission Utilities Staff (Staff) (collectively, Joint Movants) filed a Joint Motion for Procedural Schedule and Limited Waiver of Protocols, recommending an agreed schedule, with the waiver of the Protocols date for an

evidentiary hearing, for Commission review and approval.³ Having reviewed the Joint Motion, the Commission adopts the following schedule:

July 10, 2019	3:00 pm	Technical Conference, if necessary. (Held in Western's offices, with accommodation for those who cannot attend in person)
August 14, 2019	10:00 am	Status telephone conference (Call in information to be distributed later)
August 26, 2019	5:00 pm	Staff and Interveners complete the review of the Annual Update, and either file a Report and Recommendation or testimony stating that the results of the filing will result in just and reasonable rates; or, if necessary, Staff and/or Interveners shall file testimony supporting the reason(s) why the filing would not result in just and reasonable rates.
September 9, 2019	5:00 pm	Western files rebuttal testimony, if necessary.
September 23, 2019		Commission issues an order either approving the rate adjustments based on paper record or notifies parties that an evidentiary hearing will be held.
October 9, 2019	1:30 pm	One-day evidentiary hearing, if necessary.
October 23, 2019		Final Order issued if matter goes to evidentiary hearing.

- 5. Pursuant to K.S.A. 77-551(c), the Commission finds that a Prehearing Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b).
- 6. Any electronic service received after 5:00 p.m. on a deadline set forth in a procedural schedule shall be considered as filed on the next day and shall be accompanied by a Motion to File Out-of-Time.
- 7. The Prehearing Officer in this proceeding shall be Michael J. Duenes, Assistant General Counsel, Kansas Corporation Commission, 1500 SW Arrowhead Road, Topeka, Kansas,

- A. The procedural schedule set forth in paragraph 4 of this Order is adopted.
- B. Michael J. Duenes is designated as the Prehearing Officer.
- C. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁴
- D. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it deems necessary.
