**ORDER ACCEPTING AND ADOPTING
COMPLIANCE REPORT AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and determination. Having examined its files and records, the Commission finds and concludes:

1. On August 1, 2024, the Commission directed Vantage Point Solutions (VPS) to perform an audit of Metropolitan Telecommunications of Kansas, Inc. (Metropolitan) for Kansas Universal Service Fund (KUSF) purposes.

2. On February 19, 2025, VPS filed its Audit Report making findings for Metropolitan in Operating Year 27.¹ VPS recommended Metropolitan:

- a. File audit True-ups for FYs 26, 27, and 28 (through January 2025) to exclude the KUSF surcharge collected from being reported as revenue; and
- b. File an affidavit, signed by an officer of the Company, attesting that the KUSF reporting procedures were updated, including the date the corrective actions were implemented.

3. The Commission issued an Order on February 25, 2025, adopting the recommendations of VPS. On March 26, 2025, VPS issued a Compliance Report indicating Metropolitan had complied with the Commission's Order issued February 25, 2025. VPS stated Metropolitan had fulfilled all the requirements of the Order and was in compliance with Commission directives and recommended that the Docket be closed.

4. The Commission has reviewed the Compliance Report filed by VPS in this matter and finds it should be adopted, closing the Docket.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Commission accepts and adopts Vantage Point Solutions' Compliance Report, filed March 26, 2025, and determines the Docket be closed.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).²
