PREHEARING OFFICER ORDER

C. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as


provided by the Kansas Administrative Procedure Act (KAPA), K.S.A. 77-501 et seq. Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default pursuant to KAPA.

D. A corporation shall appear before the Commission by a Kansas licensed attorney.¹

E. Electronic service will be used in this proceeding, including this Order.

F. The parties have 15 days from the date this Order was electronically served to petition for reconsideration.²
