PREHEARING OFFICER ORDER CONTINUING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On January 9, 2018, the Commission issued its *Order Designating Prehearing Officer and Setting Prehearing Conference*, scheduling a Prehearing Conference in this matter for February 8, 2018.¹

2. On February 8, 2018, the parties held a Prehearing Conference and agreed to continue the proceeding another thirty (30) days to allow Staff and the Operator an opportunity to work on a possible settlement.

3. Based on the parties' desire to work on a settlement, the Prehearing Officer finds the proceeding shall be continued an additional thirty (30) days.

THEREFORE, THE PREHEARING OFFICER ORDERS:

B. Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default pursuant to the Kansas Administrative Procedure Act.²

C. A corporation shall appear before the Commission by a Kansas licensed attorney.³

D. Parties have fifteen (15) days, plus three (3) days if mailed service, in which to petition the Commission for reconsideration.⁴

E. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
