PREHEARING OFFICER ORDER

CANCELING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission has designated Samuel Feather, Deputy General Counsel, to act as Prehearing Officer in this proceeding.¹ Having reviewed the files and records, and being duly advised, the Prehearing Officer makes the following findings:

1. On January 12, 2017, the Commission issued an order directing the Operator to show cause why the Operator was not responsible for the plugging of the well identified as the Sturgeon 1² located in 26-19S-9W, N2 NW SW in Rice County, Kansas.

2. On April 6, 2016, an Order Continuing Prehearing Conference was issued by the Prehearing Officer. That order scheduled a prehearing conference for May 4, 2017.

3. On May 3, 2017, Commission Staff (Staff) filed a Motion to Cancel the Prehearing Conference and Close Docket. Staff stated, "[b]ased upon conversations with Operator and other individuals, and a full review of Commission files, Staff currently believes it is more likely than not that Operator is not responsible for the well in question." Consequently, Staff requested that the prehearing conference be cancelled and the docket be closed.
