**ADDENDUM TO APPLICATION**


COMES NOW Black Hills/Kansas Gas Utility Company, LLC, d/b/a Black Hills Energy

1.       Black Hills filed an Application in the captioned docket on June 28, 2016, for approval  
of a reduction in credit card fees.

2.       Subsequent to filing said Application, in discussions between Black Hills and Staff,  
Staff requested that Black Hills include in the record of this docket supporting documentation from




