- 1. The Commission is authorized to assess the expenses of a proceeding, opened upon its own motion, on complaint, or upon an application to it, if the expenses attributable to the investigation exceed the sum of \$100.\frac{1}{2}\$ Therefore, if the \$100 threshold is met in this matter, the Commission will assess these expenses against Kansas Gas Service, A Division of One Gas, Inc.
- 2. Expenses attributable to this docket shall be assessed beginning three (3) days after the notice of assessment is given by service of this Order. Kansas Gas Service, A Division of One Gas, Inc. is hereby notified that it has the right to request a hearing regarding this assessment in accordance with the provisions of the Kansas administrative procedure act, K.S.A.
