COMES NOW Berexco LLC ("Operator") for its application in the captioned matter states as follows:

1. Operator is a corporation authorized to do business in the State of Kansas. Operator's address is 2020 N. Bramblewood, Wichita, Kansas 67206.

2. Operator has been issued by the Kansas Corporation Commission Operator's License #34318, which expires on October 30, 2018.

Operator is the owner and operator of the Love #1-18 and Love #1-18R wells, API 3. #15-187-21333 and 15-187-21334, which are located in the Northwest Quarter of the Northeast Quarter of the Southeast Quarter of the Southeast Quarter of Section 18, Township 30 South, Range 40 West; Stanton County, Kansas ("the subject wells").

K.A.R. 82-3-100(b) states the commission may grant an exception to the 4. requirements of any of its regulations. K.A.R. 82-3-602(a)(2) limits pit extensions to two, threemonth extensions.

5. Berexco LLC requests that the Commission grant an extension, pursuant to K.A.R. 82-3-100(b), from the two, three-month extension limitation set forth in K.A.R. 82-3-602(a)(2) and allow an additional time to close drilling pits associated with the Love #1-18 and Love #1-18R wells.

6. Berexco LLC submits that due to the landowners request to line the pit with plastic, additional time is needed to allow the mud to become completely dehydrated. Due to the ground conditions, the pits have not been back filled while they are still wet in order to prevent permanent damage to the farm ground. The extension will not cause environmental harm as the pit is in accordance with KCC regulations.

7. Listed in the attached Exhibit "A" are the names and addresses of the following persons:

a. Each operator of each oil and gas lease covering lands within one-half

(1/2) mile radius of the subject well; and

B. Each person who owns any mineral interest of record in and under any lands located within one-half (1/2) mile radius of the subject well (provided that such mineral interest is not covered by any oil and gas lease).

8. Notice of this application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Operator prays that this matter be set for hearing, and upon hearing, that the Commission grant Operator's request for exception to the two, three-month extension to the pit closure time limitation pursuant to K.A.R. 82-3-602(a)(2) so as to allow the subject drilling pits to properly dehydrate.


