ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises the Commission finds and concludes as follows:

1. On November 5, 2018, P.O.&G. Operating, LLC (“Operator”) submitted an application seeking an exception to the 10-year time limitations of K.A.R. 82-3-111.¹
2. On May 9, 2019, the Operator filed a letter requesting the cancellation of the application. The letter stated that since the filing of the application the Operator determined it no longer needed the extension.² District Staff confirmed that the well was plugged on April 9, 2019.
3. In light of the Applicant’s withdrawal of the Application, the Commission finds further proceedings are unnecessary, this docket should be closed.

THEREFORE, THE COMMISSION ORDERS:

- A. This docket is closed.


B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³
