**ORDER CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined the files, the Commission finds and concludes as follows:

1.      On March 14, 2018, Kansas Gas Service, a Division of ONE Gas, Inc. ("Kansas Gas Service," and "ONE Gas," respectively) filed its Application providing its Insurance Policy Agreements with Utility Insurance Company, an affiliated company of Kansas Gas Service. On May 25, 2018, Kansas Gas Service filed an Amended Application.

2.      On August 31, 2018, Commission Staff filed its Report and Recommendation, recommending the Commission not take action pursuant to K.S.A. 66-1402 to prevent Kansas Gas Service from participating in the establishment of ONE Gas' wholly owned captive insurance company.

3.      Pursuant to K.S.A. 66-1402, "[n]o management, construction, engineering or similar contract, hereinafter made, with any affiliated interest, as defined in K.S.A. 66-1401 and amendments thereto, shall be effective unless it shall first have been filed with the commission."

The Commission has the authority to disapprove such contracts found to be not in the public interest; however, no action is required by the Commission to otherwise approve of the contract.<sup>1</sup>

4. Upon review of Staff's Report and Recommendation, the Commission adopts Staff's Report and Recommendation. This Commission finds it is appropriate to take no action and close this docket.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

(A) Staff's Report and Recommendation is adopted; the Commission takes no further action and this docket shall be closed.

(B) The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein.<sup>2</sup>

(C) The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary and proper.
