

commercial customers may be substantially affected by this proceeding.³ Accordingly, the Commission finds CURB has demonstrated an interest in this proceeding. Therefore, pursuant to K.S.A. 77-521, the Commission grants CURB's Petition for Intervention.

3. The Commission finds and concludes that CURB has met the requirements of K.A.R. 82-1-225 and should be granted intervention. CURB will be added to the official service list. Service of pleadings, communications, and correspondence should be delivered to counsel of record and CURB's other designees, as follows:

- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.


