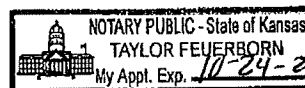

R. 21E, Franklin County, Kansas; with a maximum operating pressure of 560 psig, and a maximum injection rate of 100 bbls per day.

These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.


