

4. Granting the application will update the records of the Commission to TransWorld Network's current name, TransWorld Network, LLC, and business entity registration filed with the Kansas Secretary of State, which reported that TransWorld Network is active and in good standing.³

5. The Commission adopts Staff's analysis, findings and recommendations of October 15, 2025, as stated in the Report and Recommendation, which is attached hereto and made a part hereof by reference and finds that TransWorld Network's application should be granted.⁴ The Commission further concludes that the requested name change to TransWorld Network, LLC on the Certificates of Convenience and Authority will promote the public convenience and should be approved.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The amended application of TransWorld Network, Corp., filed herein on October 14, 2025, is hereby granted, approving the request for a name change to TransWorld Network, LLC, under its Certificates of Convenience and Authority.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁵

In the Matter of TransWorld Network Corp. Changing its Name to TransWorld Network, LLC.

EXECUTIVE SUMMARY

On March 5, 2025, TransWorld Network, Corp., (TransWorld) filed a letter requesting the Kansas Corporation Commission (Commission) change its name on all Commission records to TransWorld Network, LLC.

On October 14, 2025, TransWorld filed an amended Notice and Application with the Commission following discussions with the Commission Staff (Staff) regarding K.A.R. 82-2-219 – *General requirements relating to pleadings and other papers*. The amended Application requested a name change to TransWorld Network, LLC, on all Commission records, including its Certificates of Authority. Staff recommends approval of this Application.

BACKGROUND

The Commission derives its authority to supervise telecommunications public utilities from K.S.A. 66-2005(z). The Commission derives its authority to certificate and de-certificate public utilities from K.S.A. 66-131, which requires the Commission to review all certification and decertification applications to determine whether the “public convenience and necessity” will be promoted by granting the request.

ANALYSIS

TransWorld, formerly known as Strategic Alliances, Inc., was certified to provide resold Interexchange Service and Operator Services pursuant to Orders granting the authority in Docket

Nos. 93-STAC-184-COC and 93-STAC-477-COC, respectively. On September 6, 2024, the Company received a Certificate of Conversion/Domestication from the Kansas Secretary of State changing its name from TransWorld Network, Corp to TransWorld Network, LLC.¹

The Company, headquartered in Oldsmar, Florida, stated the name change would be transparent to the customers as it is only a change in corporate structure. Customers will continue to be billed under the name TransWorld Network, and the name change will not affect the service or rates of the services to customers. The Company, with a registered office in Topeka, is Active and in Good Standing per the Kansas Secretary of State's office and has received a Certificate of Conversion/Domestication on September 6, 2024.²

The Company has a current Annual Interrogatory on file and is current with its Commission assessments.

RECOMMENDATION

Staff recommends approval of TransWorld Network's Notice and Application reflecting the Company's name change and request to change its name in all Commission records. The Company is reminded to notify the Commission immediately of any change in address or contact telephone numbers, timely file Annual Interrogatories, maintain current registration with the Kansas Secretary of State's Office, and pay all Commission assessments in a timely manner.
