The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) submits this Motion for Leave to File Out of Time:

1. On June 5, 2025, the Commission issued its *Order Cancelling Remaining Procedural Schedule and Render a Decision on Paper Record* in the instant docket, which established that the Commission's decision would be rendered on the administrative record as it stood, with the exception of Settlement Testimony, due today, June 5, 2025.

2. The Staff witness integral to the filing of Settlement Testimony was engaged in business related to another procedure before the Commission on June 5, 2025, as well as heavily engaged in preparation for a major filing date in another matter in the days leading up to June 5, 2025.
