STATUS UPDATE ADDING WELL TO COMPLIANCE AGREEMENT AND EXTENDING FINAL COMPLIANCE DEADLINE

On February 11, 2025, the Commission issued an *Order Approving Compliance Agreement* (Agreement) in this docket. The Agreement required Operator to bring two wells into compliance with K.A.R. 82-3-111 by bringing one well into compliance by March 31, 2025, and one well into compliance per quarter thereafter. To date, Operator has brought one well into compliance. The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.

The District #2 Supervisor consents to amending this Agreement to include the Troyer OWWO #1 well, API #15-077-21186-00-01 (Subject Well). Operator has also indicated it is not opposed to the addition of the Subject Well to the Agreement. Further, Staff extends the final compliance deadline to September 30, 2025.
