STATUS UPDATE GRANTING 30-DAY EXTENSION

On February 11, 2025, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.¹ The Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.²

On September 25, 2025, Operator requested a 30-day extension of its September 30, 2025, deadline. The District #2 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Per the terms of the Agreement, Commission Staff grants a 30-day extension of Operator's deadline to October 30, 2025. All other remaining deadlines under the Agreement remain the same.
