STATUS UPDATE TO COMPLIANCE AGREEMENT

On August 20, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. The Agreement provides that upon good cause shown, CEC Operations LLC (Operator) may receive an extension of time to achieve compliance for up to 30 days from the applicable deadline, if Operator requests an extension at least seven days prior to the applicable deadline.¹

On March 18, 2021, Operator requested an extension of time from its March 31, 2021, deadline in order to plug, return to service, or repair and TA the well(s) subject to this deadline. Commission Staff's District #2 Supervisor believes Operator has demonstrated weather related good cause for making its request and recommends approval of Operator's request and extending Operator's March 31, 2021 deadline to April 30, 2021.

Staff would note Operator is currently in compliance with their agreement and recommends approving Operators request for an extension of time.
