PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). The Commission has designated Samuel Feather, Deputy General Counsel, to act as Prehearing Officer in this proceeding. Having reviewed the files and records, and being duly advised, the Prehearing Officer makes the following findings:

1. On July 17, 2017, Commission Staff filed a Motion for an Order to Show Cause, the Designation of a Prehearing Officer, and the Scheduling of a Prehearing Conference. Staff stated "on December 8, 2014, Operator filed Notice of Intent to Drill (C-1) Form and Application for Surface Pit (CDP-1) Form for its proposed Dirks #27-2 well...." Staff approved the C-1 and CDP-4 for the subject well on December 8, 2014. Operator filed a Well Completion (ACO-1) Form on June 15, 2015, "indicating the subject well was spud on January 8, 2016, and completed on March 19, 2015." Operator filed a Closure of Surface Pit (CDP-4) Form on March 31, 2016, stating the pit was closed on October 22, 2015.⁴

- 2. On August 22, 2017, the Commission issued an Order to Show Case, Designating a Prehearing Officer, and Setting a Prehearing Conference. The Order set a Prehearing Conference for October 2, 2017 at 10:30 am.⁵
- 3. On September 27, 2017, counsel for the Operator contacted the Office of General Counsel and requested the Prehearing Conference be rescheduled to November 13, 2017 at 11:30 am. Staff has indicated that it does not object to the requested change.

THEREFORE, THE PREHEARING OFFICER ORDERS:

- A. A Status Conference shall be held on **Monday, November 13, 2017, at 11:30** a.m., by telephone. The conference call information is: telephone number: (866) 620-7326, Conference Code PIN #7632914771.
- B. At the Status Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the Status Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.⁶
- C. The parties have 15 days, plus three days if mailed, from the date of service of this Order to petition for reconsideration.⁷
- D. The Commission retains the jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it deems necessary.
