This letter is submitted on behalf of West Telecom Services, LLC ("Company") in response to the Commission's Order In the Matter of a General Investigation into the Adjustment of Intrastate Switched Access and Reciprocal Compensation Charges Pursuant to the Federal Communications Commission's Reforms, Docket No. 18-GIMT-448-GIT. The Company's current intrastate switched access rates refer to the corresponding interstate access rates as set forth in the Company's Tariff FCC No. 1, on file with the Federal Communications Commission. In compliance with the requirements of the Federal Communications Commission Report and Order in WC Docket No. 10-90, *et. al.*, FCC No. 11-161, the seventh phase of intercarrier compensation transition will be implemented with a revision of the Company's interstate access rates to benchmark ILEC rates effective August 2, 2018.
