**ORDER REINSTATING INTRASTATE MOTOR CARRIER OPERATIONS**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

**I. JURISDICTION AND BACKGROUND**

1. Pursuant to K.A.R. 82-4-1b, 66-1,111, 66-1,112, 66-1,114, 66-1,114b and 66-1,115, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.

2. Pursuant to K.S.A. 66-1,129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in

regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

3. Pursuant to K.S.A. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3f) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

## **II. FINDINGS OF FACTS**

4. Andy Bond, d/b/a Bond Trucking of Liberal, Kansas (Respondent) is a motor carrier as defined in K.A.R. 82-4-3f, that operates commercial motor vehicle(s) in intrastate commerce.

5. Respondent operates under USDOT Number 816017.

6. On December 10, 2019, Transportation Staff filed a Motion to Suspend Intrastate Motor Carrier Operations due to Respondent's non-compliance with ordering clause B of the Penalty Order issued to it on October 2, 2018. Ordering clause B requires the carrier to submit to one follow-up safety compliance review within the next 18 months.

7. On December 17, 2019, the Commission issued an Order Suspending Intrastate Motor Carrier Operations on Respondent based on Staff's motion.

8. Transportation Staff has advised that Respondent contacted him and has provided the necessary documentation for a safety compliance review.

9. Staff recommends Respondent's motor carrier operations be reinstated.

### **III. CONCLUSIONS OF LAW**

10. The Commission finds it has jurisdiction over Respondent as the Respondent is a motor carrier as defined in K.A.R. 82-4-3f.

11. The Commission concludes that Respondent has complied with conducting a safety compliance review and, therefore, its intrastate motor carrier operations should be reinstated.

#### **THE COMMISSION THEREFORE ORDERS THAT:**

A. Andy Bond, d/b/a Bond Trucking's intrastate motor carrier operations is hereby reinstated.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders, as necessary.
