This is a notice of a penalty assessment against Javier G Morales d/b/a J's Trucking (J's Trucking) for violation(s) of Kansas Motor Carrier Safety Statutes, Rules, and Regulations discovered during a compliance review conducted on August 17, 2023, by Kansas Corporation Commission Special Investigators Erica Pargas and Penny Fryback. Penalties are assessed in accordance with the FY 2024 Uniform Penalty Assessment Matrix, approved by the Commission on June 29, 2023. For a full description of the penalty(s) and terms and obligations please refer to the Order attached to this notice.

IF YOU ACCEPT THE PENALTY: J's Trucking has been assessed a \$3,350 penalty. You have thirty (30) days from the date of service of the Penalty Order to pay the penalty. Please remit payment of \$3,350, through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network (KTRAN) system located at https://puc.kcc.ks.gov/ktran/. If you have not received a letter from the Transportation Division assigning you a PIN, please contact that Division at 785-271-3145. You must have an account through KTRAN to pay the penalty owed.

The attached Order requires a representative of J's Trucking to attend a Commission-sponsored safety seminar within ninety (90) days from the date of the Order and to provide the undersigned Litigation Counsel with written proof of attendance. A schedule of dates and locations for safety seminars can be found at the Commission's website http://www.kcc.state.ks.us/trans/safety meetings.htm.

IF YOU CONTEST THE PENALTY ORDER: You have the right to request a hearing. A request for a hearing must be made in writing, setting forth the specific grounds upon which relief is sought. J's Trucking must file, within fifteen (15) days from the date of service of this Order, the request for hearing with the Commission's electronic filing system found at https://puc.kcc.ks.gov/e-filing/e-express/, and mail a copy of the request for hearing to the undersigned at the above address. If you do not have access to the internet, you can mail an original and seven copies of the request to the Executive Director at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy to the undersigned Litigation Counsel.1

<u>IF YOU FAIL TO ACT:</u> Failure to pay the penalty of \$3,350 within thirty (30) days from the date of service of the Penalty Order or failure to comply with the terms of the Order, or in the alternative, failure to provide a timely written request for a hearing, will result in the Order becoming final and may result in additional sanctions of suspension and/or revocation of your motor carrier operating authority.

PENALTY ORDER

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On August 17, 2023, Commission Staff Special Investigators (SIs) Erica Pargas and Penny Fryback, completed a safety compliance investigation of the operations of Javier G Morales d/b/a J's Trucking (J's Trucking or Carrier). J's Trucking is a motor carrier as defined in 49 C.F.R. 390.5, and operates under USDOT number 2560333.
- 2. On October 9, 2023, Staff submitted its Report and Recommendation (R&R), attached hereto as Attachment "A" and is hereby incorporated by reference, recommending a penalty of \$3,350 to be issued to J's Trucking based on the frequency, timeline and severity of the violations discovered. Staff's R&R indicates that as a result of the safety compliance investigations, SIs Erica Pargas and Penny Fryback identified fifty-nine (59) violation(s),

accounting for five (5) count(s), of the Motor Carrier Safety Regulations (MCSRs), which carry a penalty according to the FY2024 Uniform Penalty Assessment Matrix.²

- 3. Additionally, Staff recommends that J's Trucking be required to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within ninety (90) days from the date of this Order, and provide Litigation Counsel with written proof of attendance.³ A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety meetings.htm.
- 4. Staff further recommends J's Trucking submit a written, comprehensive corrective action plan (CAP) to Transportation Staff within thirty (30) days of the date of this order, documenting the violation(s) described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.⁴
- 5. Finally, Staff recommends that J's Trucking submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order.⁵ Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for this review.
- 6. Pursuant to K.S.A 66-1,108b, 66-1,111, 66-1,112 and 66-1,114b, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in 49 C.F.R. Part 390.5 as adopted by K.A.R. 82-4-3f, doing business or procuring business in

Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority and jurisdiction.

- 7. Pursuant to K.S.A. 66-1,129a, 66-1,130 and 66-1,142b, the Commission may suspend operations, revoke or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision or regulation of the Commission.
- 8. The Commission has the authority, pursuant to K.A.R. 82-1-237, to investigate an entity under the Commission's jurisdiction and issue an order on the Commission's own motion when the Commission believes the entity is in violation of the law or any order of the Commission.

IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. Javier G Morales d/b/a J's Trucking, of Garden City, KS is hereby assessed a \$3,350 civil penalty for fifty-nine (59) violation(s), accounting for five (5) count(s), of Kansas law governing the regulation of motor carriers, the Kansas Administrative Regulations and provisions of the Federal Motor Carrier Safety Regulations, as adopted by the Kansas Administrative Regulations.
- B. J's Trucking is hereby ordered to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within ninety (90) days from the date of this Order, and is to provide Litigation Counsel with written proof of attendance.
- C. Carrier is hereby ordered to submit a written, comprehensive corrective action plan (CAP) to Transportation Staff within thirty (30) days of the date of this order, documenting

the violation(s) described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.

- D. J's Trucking is ordered to submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order. Transportation Staff will contact the Carrier to set up the appointment.
- E. Pursuant to K.S.A. 77-537 and K.S.A. 77-542, any party may request a hearing on the above issue(s) by submitting a written request setting forth the specific grounds upon which relief is sought. The request may be electronically filed with the Commission's electronic filing system at https://puc.kcc.ks.gov/e-filing/e-express/, within fifteen (15) days from the date of service of this Order, and a copy of the request mailed to the Litigation Division. If you do not have access to the internet, you can mail an original and seven copies of the request to the Executive Director at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy of the request to Litigation Counsel. A hearing will be scheduled only upon written request. Failure to timely request a hearing will result in a waiver of J's Trucking's right to a hearing, and this Penalty Order will become a Final Order.
- F. If a request for hearing is filed, attorneys for all parties shall enter their appearances in Commission proceedings by giving their names and addresses for the record. For civil penalties exceeding \$500, a corporation shall appear before the Commission by its attorney, unless waived by the Commission for good cause shown and a determination that such waiver is in the public interest.⁶
- G. If you do not request a hearing, the payment of the civil penalty of \$3,350 is due in thirty (30) days from the date of service of this Order. Payment of \$3,350 must be made

through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network (KTRAN) system located at https://puc.kcc.ks.gov/ktran/. You must have an account through KTRAN to pay the penalty.

H. Failure to pay the \$3,350 civil penalty within thirty (30) days from the date of service of this Penalty Order and/or failure to comply with the provisions of this Order may result in suspension of J's Trucking's motor carrier operating authority without further notice.⁷ Additionally, the Commission may impose further sanctions to include, but not limited to, the issuance and enforcement of revocation of authority and/or cease and desist orders, and any other remedies available to the Commission by law, without further notice.

EXECUTIVE SUMMARY:

Javier G Morales is a motor carrier (MC) possessing public for-hire operating authority from the Commission, primarily hauling grain, feed and hay. Javier G Morales operates under USDOT 2560333. On August 17, 2023, Commission Staff Special Investigators (SIs) Erica Pargas and Penny Fryback completed a safety compliance investigation of the operations of Javier G Morales. A copy of the safety compliance report is attached hereto as **Exhibit 1** and is hereby incorporated by reference. As a result of this investigation, the SIs identified fifty nine (59) violation(s), accounting for five (5) specific count(s), of the Motor Carrier Safety Regulations (MCSRs), which carry a penalty according to the FY2024 Uniform Penalty Assessment Matrix approved by the Commission. Based on the frequency, timeline and severity of the violations discovered by the SIs, staff recommends penalty of \$3,350 be issued to the MC.

DISCUSSION AND ANALYSIS:

On August 17, 2023, Commission Staff SIs Erica Pargas and Penny Fryback conducted a safety compliance investigation of the operations of Javier G Morales. The investigation covers a 365 day period. Each specific count is detailed below.

Count One (1 of 5)

<u>Juris diction:</u> 49 C.F.R. 395.8, adopted by K.A.R. 82-4-3a, and authorized by K.S.A. 66-1,129 <u>Intent of Law:</u> The MC shall require its driver to keep records of duty status for each 24-hour period using the method described in 49 C.F.R. 395.8(a) and to submit the original record to the

motor carrier within 13 days of creation.

Supporting Documentation: On May 18, 2023, Javier G. Morales required or permitted its driver, Francisco J. Morales, Jr., to operate a commercial driver's license (CDL) required commercial motor vehicle (CMV), a 1994 Peterbilt, VIN ending in 0306, GVWR 50,000 lbs., in interstate commerce from Minden, Nebraska to Satanta, Kansas. This transport is evidenced by a trip sheet, attached hereto as **Exhibit 2**. On this transport, the driver went beyond the 150 air mile radius and was therefore required to prepare a record of duty status for the portion of the trip beyond 150 air miles.

<u>Violation:</u> Javier G. Morales failed to require driver to prepare a record of duty status (**Exhibit 1**, **Page 3**). Twenty Four (24) violation(s) were discovered.

Recommendation: Staff recommends a fine of \$750.

Count Two (2 of 5)

<u>Juris diction</u>: 49 C.F.R. 395.8(k), adopted by K.A.R. 82-4-3a, and authorized by K.S.A. 66-1,129. <u>Intent of the Law</u>: The MC shall obtain from its drivers and retain supporting documents and the record of duty status for a period of six (6) months.

<u>Supporting Documents:</u> This violation took place during the transport described in Count One, above. The MC failed to retain copies of bills of lading, scale tickets and/or fuel receipts for the loads hauled by its driver.

<u>Violation:</u> Javier G. Morales failed to retain supporting documents (Exhibit 1, Page 3). Thirty (30) violation(s) were discovered.

Recommendation: Staff recommends a fine of \$900.

Count Three (3 of 5)

<u>Juris diction:</u> 49 C.F.R. 396.17, adopted by K.A.R. 82-4-3j, and authorized by K.S.A. 66-1,129. <u>Intent of the Law:</u> The MC shall obtain and document a successful periodic (annual) inspection on the commercial motor vehicle during the preceding 12-month period. The inspection shall be retained by the MC pursuant to 49 C.F.R. 396.21(b).

<u>Supporting Documents:</u> On June 21, 2023, Javier G. Morales required or permitted its driver, Francisco J. Morales, Jr., to operate a CDL-required CMV, a 1994 Peterbilt, VIN ending in 0306, GVWR 50,000 lbs., in intrastate commerce from Garden City, Kansas to Belpre, Kansas. This transport is evidenced by a Driver Vehicle Examination Report No. KSHP04501877, attached hereto as **Exhibit 3**. At the time of this transport, the MC failed to have a current annual inspection on the CMV being operated.

<u>Violation:</u> Javier G. Morales was found to be in violation of using a CMV that had not been periodically inspected (Exhibit 1, Page 3 to 4). Two (2) violation(s) were discovered.

Recommendation: Staff recommends a fine of \$750.

Count Four (4 of 5)

Juris diction: 49 C.F.R. 396.3, adopted by K.A.R. 82-4-3j, and authorized by K.S.A. 66-1,129.

<u>Intent of the Law:</u> The MC shall have records indicating the nature and due date of the inspections and maintenance operations to be performed on the commercial motor vehicles.

<u>Supporting Documents:</u> This violation took place during the transport described in Count Three, above. Carrier failed to produce any maintenance records. The MC failed to provide the SIs with maintenance records for the CMVs operated.

<u>Violation:</u> Javier G. Morales failed to maintain records of inspection and maintenance (**Exhibit 1**, **Page 4**). Two (2) violation(s) were discovered.

Recommendation: Staff recommends a fine of \$750.

Count Five (5 of 5)

<u>Juris diction</u>: 49 C.F.R. 396.11, adopted by K.A.R. 82-4-3j, and authorized by K.S.A. 66-1,129. <u>Intent of the Law</u>: The MC shall require its driver to prepare a Driver Vehicle Inspection Report (DVIR) in writing at the completion of each day's work on each vehicle operated if a defect is discovered and to submit copies of the reports to the motor carrier for action and record retention. <u>Supporting Documents</u>: This violation took place during the transport described in Count Three, above. The MC failed to provide the SIs with DVIRs prepared by its driver.

<u>Violation:</u> Javier G. Morales failed to require its driver to prepare DVIRs as required (**Exhibit 1**, **Page 4 to 5**). One (1) violation was discovered.

Recommendation: Staff recommends a fine of \$200.

RECOMMENDATION:

Transportation Staff recommends the Commission find Javier G Morales committed fifty nine (59) violation(s) accounting for five (5) specific counts of Kansas law that governs MCs, including various provisions of the Federal Motor Carrier Safety Regulations (FMCSRs), as adopted by the Kansas Administrative Regulations (K.A.R.s), and is therefore subject to sanctions or fines imposed by the Commission.


Due to the frequency, timeline and severity of the violations, Staff recommends a civil penalty of \$3,350 for fifty nine (59) violation(s) of the MC Safety Statutes, Rules and Regulations, in accordance with the recommended penalties listed in the applicable Uniform Penalty Assessment Matrix.

Staff further recommends Javier G Morales require a representative responsible for the company's safety to attend a Commission-sponsored safety seminar within ninety (90) days from the date of the Order, and provide Litigation Counsel with written proof of attendance. A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety meetings.htm.

Staff further recommends Javier G Morales submit a written, comprehensive Corrective Action Plan (CAP) to Transportation Staff within thirty (30) days of the date of this order, documenting the violation(s) described in the Penalty Order, including specific and detailed

information explaining the carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.

Finally, Staff recommends that Javier G Morales submit to one follow-up safety compliance review within eighteen (18) months from the date of the Penalty Order. Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for the review.




