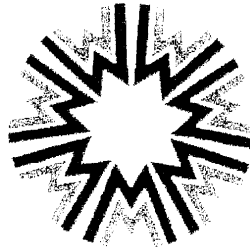

Midwest hereby submits its monthly Gas Purchase Contract Summary as required by the above-captioned Order for the month ended December 31, 2001.

Pursuant to the instructions contained in a letter from Assistant General Counsel Otto Newton of November 13, 2001 we hereby formally request the establishment of a formal docket specific to Midwest Energy, Inc. for the purpose of filing future Gas Purchase Reports, establishment of annual gas portfolio reviews, and other matters as required by the terms of the June 21, 2001 Order.
