**ORDER DESIGNATING NEW PREHEARING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1.        On November 20, 2018, the Commission issued a *Penalty Order* against Jordan Oil Management, Inc. (Operator) for two violations of K.A.R. 82-3-111 because the subject wells have been inactive in excess of the time allowed by regulation without being plugged, returned to service, or approved for TA status.<sup>1</sup>

2.        The Commission designates Jonathan R. Myers, Assistant General Counsel, 266 N. Main Street, Suite 220, Wichita, KS 67202, 316-337-6245, [j.myers@kcc.ks.gov](mailto:j.myers@kcc.ks.gov), as the new Prehearing Officer.<sup>2</sup> The Prehearing Officer may conduct Prehearing Conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.
