

4. In a letter hand delivered on November 3, 2019, Respondent requested a hearing before the Commission.

5. On December 31, 2019, the Commission issued its Order Designating Prehearing Officer and Setting Prehearing Conference, which set a Prehearing Conference for Thursday, January 9, 2020 at 9 a.m.

6. By agreement of the parties, the prehearing conference was rescheduled for Friday, January 10, 2020.

7. On January 10, 2020 a Prehearing Conference was held, wherein Staff and Respondent agreed that Staff would obtain dates from the Commission and then informally agree to a procedural schedule with Respondent.

8. On January 23, 2020, after confirming the availability of witnesses for a proposed hearing date, Counsel for Staff contacted Respondent about a hearing date. Respondent agreed to the proposed hearing date.

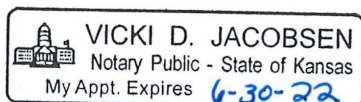
