


WHEREFORE, based upon Operator's email withdrawing its request for hearing, and as no issues remain to be resolved, Staff moves the Commission for this docket to be closed.



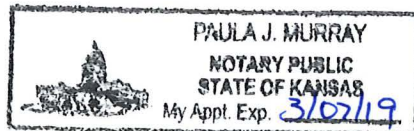
