#### JOINT MOTION TO LIFT STAY AND MODIFY PROCEDURAL SCHEDULE

Southern Pioneer Electric Company (Southern Pioneer), the Kansas Power Pool (KPP) and Mid-Kansas Electric Company, LLC (Mid-Kansas), (collectively, Joint Movants) respectfully move the Commission for an order lifting the stay of the procedural schedule instituted in the Commission's Order Granting Stay issued on May 2, 2017, and modifying the Order Adopting Procedural Schedule issued on March 30, 2017. In support of its Joint Motion, Joint Movants state as follows:

- 1. On September 9, 2016, Southern Pioneer filed a Formal Complaint against KPP (Complaint). On December 15, 2016, the Commission subsequently accepted the Complaint and caused it to be served on KPP.
  - 2. On December 22, 2016, KPP filed its Answer to the Complaint.
- 3. On March 10, 2017, Mid-Kansas petitioned for intervention, and the Commission granted the intervention on March 30, 2017.
- 4. On March 30, 2017, the Commission issued its Procedural Order setting forth the following deadlines:

- 5. On April 4, 2017, Southern Pioneer and KPP met for the purposes of informally discussing settlement. As a result of those discussions, Southern Pioneer and KPP desired to explore various options that could result in resolution of the issues in this proceeding. However, due to the complexity of the issues, additional time was needed to fully explore the potential settlement options.
- 6. As such, on April 17, 2017, Joint Movants filed a Joint Motion to Stay Procedural Schedule to allow the parties to focus efforts on settlement rather than the drafting of testimony.
- 7. On May 2, 2017, the Commission issued an Order Granting Stay, granting the Joint Motion to Stay Procedural Schedule, staying the proceeding for sixty (60) days, and requiring that Joint Movants provide to the Commission a proposed amended procedural schedule at the completion of the sixty (60) days.
- 8. On June 2, 2017 the Joint Movants submitted to the Commission a status report, stating that despite settlement discussions, Southern Pioneer and KPP have been unable to reach a full resolution of the issues at this time, and further stating that the Joint Movants intend to file a motion to lift the stay and/or provide the Commission with a proposed amended procedural schedule within the next thirty (30) days.

9. Accordingly, the Joint Movants hereby request a lift of the stay of the procedural schedule and approval of the proposed amended procedural schedule as follows:
