JOINT MOTION FOR PROCEDURAL SCHEDULE AND LIMITED WAIVER OF PROTOCOLS

COMES NOW, the Western Cooperative Electric Association, Inc. ("Western"), the Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), Kansas Electric Power Cooperative, Inc. ("KEPCo"), and the Kansas Power Pool ("KPP") (collectively referred to as "Joint Movants") hereby move the Commission for an Order establishing a procedural schedule and granting a limited waiver in the above-captioned matter. In support of their motion, Joint Movants state the following:

1. On April 26, 2019, Western filed its Application seeking approval to update its local access delivery service tariff pursuant to the 34.5kV formula-based rate plan ("34.5kV FBR") approved in Docket No. 16-MKEE-023-TAR.

2. On May 2, 2019, KPP filed a Petition to Intervene.

3. On May 14, 2019, KEPCo filed an Entry of Appearance.

4. In informal discussions between parties, Western, Staff, KEPCo, and KPP indicated their willingness to collaborate on a schedule that adheres to the 34.5kV FBR protocols.

5. To the best of Joint Movants' abilities at this time, the proposed schedule takes into consideration the 34.5kV FBR protocols (with a limited exception as explained below), as well as individual scheduling concerns of all parties and the Commission. The proposed procedural schedule agreed to by Joint Movants is as follows:

and reasonable rates; or, if necessary, Staff	
and/or Interveners shall file testimony	
supporting the reason(s) why the filing would	
not result in just and reasonable rates.	
Western files rebuttal testimony, if necessary	September 9 th
Commission issues an order either approving	
the rate adjustments based upon the paper	September 23 rd
record or notifying the parties that an	
evidentiary hearing will be held.	
A one-day evidentiary hearing will be set	
during this time in case it is needed based	October 9 th at 9:00 am
upon the Commission 150 day Order.	
Final Order issued if the matter goes to	October 23 rd
evidentiary hearing.	

6. Joint Movants recognize that the one day evidentiary hearing in the aforementioned procedural schedule falls outside of the range of dates required by the 34.5kV FBR protocols. The parties have agreed to a date differing from the 34.5kV FBR protocols for the evidentiary hearing in order to accommodate a conflict with the Commission's calendar during the time period required for any necessary evidentiary hearing under the 34.5kV FBR protocols and, therefore, request a limited waiver of the 34.5kV FBR protocols in this instance only.

WHEREFORE, Joint Movants respectfully request the Commission issue an order granting this Joint Motion, approving the procedural schedule as set forth above, granting the limited waiver as described herein, and for any other relief the Commission deems just and reasonable. Respectfully submitted,
