#### ORDER CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On January 28, 2016, Commission Staff moved the Commission to set this matter for hearing, alleging that an unplugged well was located on the Operator's license.
- 2. On March 17, 2016, the Commission issued its Order to Show Cause, Designating a Prehearing Officer, and Setting a Prehearing Conference.
- 3. On May 31, 2016, the Prehearing Conference was held, and Operator did not attend. Commission Staff moved the Prehearing Officer to propose a default order.
- 4. On April 12, 2016, the Commission issued its Default Order. Operator moved to vacate on April 22, 2016, and the Commission affirmed its Default Order on May 19, 2016.
- 5. On July 12, 2016, Commission Staff moved the Commission to close this docket, explaining Operator had plugged the well at issue and the matter was complete.
- 6. The Commission finds and concludes that the proceedings in this matter should be cancelled, and the docket should be closed.

### THEREFORE, THE COMMISSION ORDERS:

- A. The proceedings in this matter are cancelled, and this docket shall be closed.
- B. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
