**ORDER GRANTING WITHDRAWAL AND CLOSING DOCKET**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed its files and record and being duly advised in the premises, the Commission makes the following findings:

1.        On June 29, 2021, Cable One VoIP LLC (Cable One) filed an Application requesting the Commission to designate it as an Eligible Telecommunications Carrier (ETC) to provide Lifeline-only services in Kansas.

2.        Cable One evaluated providing service under the Emergency Broadband Benefit Program administered by the Federal Communications Commission, rather than proceeding with ETC designation in this Docket.

3.        Based on its review, Cable One filed a request to withdraw its Application in this Docket on September 17, 2021.

4.        On review of the request, the Commission finds that withdrawal should be granted and the Docket be closed.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. The Cable One VoIP LLC request to withdraw its ETC Application is hereby granted without prejudice to its rights and interests. Accordingly, the Docket is closed.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.
