JOINT MOTION TO APPROVE STIPULATION AND AGREEMENT

COMES NOW, the Staff of the State Corporation Commission of the State of Kansas ("Staff' and "Commission" respectively), Midwest Energy, Inc. ("Midwest"), and the Citizens' Utility Ratepayer Board ("CURB) (collectively, "Joint Movants") and respectfully move the Commission for an Order approving the Stipulation and Agreement ("Stipulation") filed concurrently with this Motion. In support thereof, Joint Movants state as follows.

- 1. Midwest filed an application for approval to make certain changes in its charges for electric service on December 21, 2007.
- 2. A petition to intervene by CURB was filed with the Commission on December 26, 2007.
- 3. On February 25, 2008, the Commission issued an Order Granting Intervention to CURB and Establishing Procedural Schedule. In that order, an evidentiary hearing was scheduled for June 17, 2008.
- 4. No other parties have petitioned the Commission for intervention in the above captioned docket.

- 5. The parties have continued to work to resolve the matter. Joint Movants filed a Joint Motion for Continuance on June 11, 2008.
- 6. By order dated June 12, 2008, the Commission continued the evidentiary hearing until June 23, 2008 to allow the parties to file the Stipulation on June 16, 2008, and testimony in support of the Stipulation by June 18, 2008.
- 7. The Stipulation and Agreement in the above captioned docket is hereby adopted by reference and filed concurrently to this Joint Motion.

WHEREFORE, Joint Movants respectfully request that the Commission approve the Stipulation as proposed by the signatory parties thereto.
