#### ORDER SUSPENDING INTRASTATE MOTOR CARRIER OPERATIONS

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

#### I. JURISDICTION AND BACKGROUND

1. Pursuant to K.S.A. 66-1,111, 66-1,112, and 66-1,114b, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction. Pursuant to K.S.A. 66-1,142b the Commission is granted the authority to prescribe reasonable rules and regulations for the assessment of administrative civil penalties and sanctions for violations of any statute, commission orders or rules and regulations adopted by the commission.

- 2. Pursuant to K.S.A. 66-1,129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.
- 3. Pursuant to K.S.A. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3f) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

#### II. FINDINGS OF FACTS

- 4. On October 17, 2022, Commission Staff filed a Motion to Suspend Intrastate Motor Carrier Operations due to the carrier's failure to pay.
- 5. Staff advised that Long Haul Trucking LLC of Shawnee, Kansas (Carrier) is a motor carrier as defined in K.A.R. 82-4-3f, which operates commercial motor vehicle(s) in intrastate commerce and operates under USDOT Number 2901327.
- 6. On July 28, 2022, the Commission issued Carrier a Penalty Order in this docket that assessed a civil penalty of \$1,900 for violations of the Kansas Motor Carrier Safety Statutes, Rules and Regulations discovered during a compliance review conducted by Special Investigators Matt Adams on June 8, 2022.
- 7. The Carrier had 30 days from the date served to pay the civil penalty of \$1,900.

- 8. Carrier was sent a collection letter on September 14, 2022, reminding it of the civil penalty issued in this docket and giving it 10 days from the date of the collection letter to pay.
- 9. As of November 7, 2022, Commission records indicate that Carrier has not complied with the collection letters or the requirements of the Penalty Orders.
- 10. Staff recommends the Commission place Long Haul Trucking LLC out-of-service due to its failure to comply with the Commission's Penalty Order.

#### III. CONCLUSIONS OF LAW

- 11. The Commission finds it has jurisdiction over Carrier as it is a motor carrier as defined in 49 C.F.R. 390.5 and as adopted by K.A.R. 82-4-3f.
- 12. The Commission finds Carrier received sufficient notice of the Commission's Penalty Order and the requirement to pay the fine within 30 days from the date of service of the Penalty Order.
- 13. The Commission finds Carrier's failure to comply with the requirements of the Penalty Order issued July 28, 2022, and therefore this Commission finds the Carrier should be suspended from all intrastate motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 66-1,129, until such time as the carrier takes the necessary steps to become compliant.

#### THE COMMISSION THEREFORE ORDERS THAT:

A. Long Haul Trucking LLC of Shawnee, Kansas is immediately suspended from all intrastate commercial motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 66-1,129, until such time as Carrier pays the civil fines totaling \$1,900 and brings its motor carrier operation

into compliance with motor carrier safety statutes, rules and regulations. This Suspension

of Intrastate Motor Carrier Operations Order may also attach and apply to the operations

of successor entities, including any motor carrier entity or entities established or used to

avoid the consequences of any Order to cease operations or suspending operating authority.

Pursuant to K.S.A. 77-537 and K.S.A. 77-542, any party may request a

hearing on the above issues by submitting a written request, setting forth the specific

grounds upon which relief is sought, to the Executive Director, at 1500 S.W.

Arrowhead Road Topeka, Kansas 66604 within fifteen (15) days from the date of

service of this Order. Pursuant to K.S.A. 66-1,129a, hearings will be held within ten (10)

days upon written request. Failure to timely request a hearing will result in a waiver of

Carrier's right to a hearing, and this Order will become a Final Order.

C. Attorneys for all parties shall enter their appearances in Commission

proceedings by giving their names and addresses for the record. For civil penalties

exceeding \$500, a corporation shall appear before the Commission by its attorney, unless

waived by the Commission for good cause shown and a determination that such waiver is

in the public interest. K.S.A. 77-515(c); K.A.R. 82-1-228(d)(2); K.A.R. 82-1-202(a).

Failure to comply with the provisions of this Order may result in further D.

sanctions to include, but not limited to, the assessment of civil penalties and/or the

impoundment of commercial motor vehicles found operating in violation of this Order and

any other remedies available to the Commission by law, without further notice.
