**ORDER GRANTING STAFF'S MOTION FOR CONTINUANCE**

The Staff's Motion for Continuance filed on April 18, 2011, comes before the State Corporation Commission of the State of Kansas (Commission) for consideration. The Commission, being duly advised in the premises, and after having examined its files and records, finds and concludes as follows:

1.     On May 4, 2011, the Kansas Highway Patrol issued a Notice of Violation against EEI, LLC (Respondent) for alleged violations found during an April 27, 2011, routine motor carrier stop and inspection conducted by the Kansas Highway Patrol.
2.     On July 11, 2011, Respondent's counsel, Jason P. Hoffman of Hoffman & Hoffman, filed a Request for Hearing on behalf of Respondent.
3.     On July 12, 2011, Commission Staff (Staff) issued a Notice of Hearing which set the matter for hearing by the Commission on August 11, 2011, at 11:30 a.m., and established deadlines for prefiled testimony.

4. On July 26, 2011, Staff and Mr. Hoffman discussed and agreed to the need for a continuance of the hearing date and an extension of testimony filing deadlines due to Respondent's participation in a parallel case being heard in district court.

5. Staff therefore requests that the hearing in this matter be continued until October 13, 2011, at 10:00 a.m.; that the filing date for the parties' prefiled direct testimony be extended to ten days prior to the extended hearing date, and that the rebuttal testimony be presented at the hearing in October 2011. In its Motion for Continuance, Staff requested the Commission issue an order continuing the hearing to June 22, 2011, at 10:30 a.m. The filing date for the parties' prefiled direct testimony should also be extended to ten (10) days prior to the extended hearing date; and that any rebuttal testimony of the parties be presented at the hearing.

6. The Commission finds that it is reasonable to grant Staff's Motion and continues the evidentiary hearing on this matter from May 12, 2011 to June 22, 2011, at 10:30 a.m.; and extends the filing date for the parties' prefiled direct testimony to ten (10) days prior to the extended hearing date; and any rebuttal testimony of the parties shall be presented at the hearing.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. Staff's Motion for Continuance is granted and the hearing will be continued to June 22, 2011, at 10:30 a.m. The parties' prefiled testimony will be due ten (10) days prior to that date and any rebuttal testimony of the parties will be presented at the hearing.

B. The parties have thirty (30) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission

for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 66-1,105; K.S.A. 77-529.

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary.
