- 1. On January 30, 2018, H & C Operating, Inc. ("Operator") submitted an application seeking injection authority at the subject well.
- 2. On February 20, 2018, the Commission received a protest to the application from Curtis Brungardt, North Fork Farms, LLC ("Protestant"), and on March 07, 2018, Staff received a request for hearing from Protestant.
- 3. On April 26, 2018, the Commission issued an Order Designating Prehearing Officer and Setting Prehearing Conference in this matter for May 15, 2018.
- 4. On April 26, 2018, Staff received a request from Protestant to withdraw their protest, which is attached to this motion.
- 5. As the protest in this matter has been withdrawn, this docket is no longer contested. Since the Commission has authorized the Conservation Division to take all actions with regard to injection wells without a Commission order in uncontested matters, Staff moves

the Commission to close this docket, authorizing Staff to process Operator's application administratively.¹

WHEREFORE, for the reasons described above, Staff respectfully moves the Commission to close the docket so that Staff may process the application as appropriate.


