## MOTION TO EXTEND DATE FOR FILING INFORMATION REQUIRED BY K.A.R. 82-1-231

COMES NOW the S & T Telephone Cooperative Association, Inc. (S&T), by and through its attorney Colleen R. Harrell of JAMES M. CAPLINGER, CHARTERED, and respectfully moves the Commission to extend the date for filing the information required by K.A.R. 82-1-231 as previously ordered. In support of its motion, S&T shows the Commission as follows:

- 1. On October 7, 2011, the Staff of the State Corporation Commission of Kansas (Staff and Commission, respectively) filed its motion requesting the Commission order S&T to submit to an audit to determine whether its cost-based Kansas Universal Service Fund (KUSF) support should be adjusted, pursuant to K.S.A. 66-2008(e).
- 2. The Commission issued an Order on December 9, 2011 in this docket granting Staff's motion and setting forth March 15, 2012 as the date S&T must file the information required by K.A.R. 82-1-231.
- 3. Kevin Kelly, of TCA, Inc., and S&T's cost consultant, has had a recent loss in his family and, as a result, has been away from the office and has been unable to work on this matter. Mr. Kelly will be the main witness prefiling testimony in support of S&T's K.A.R. 82-1-231 filing. S&T requests that because of the extraordinary and unforeseeable circumstances the Commission grant an extension to March 23, 2012 for S&T to file the information required by

K.A.R. 82-1-231. S&T's counsel contacted the Commission's Staff and Staff has no objection to S&T's request to extend the filing date to March 23, 2012. Further, S&T notes that no procedural schedule has yet been set by the Commission in this docket and, as such, an extension of only eight days will not impact or prejudice any party to this docket or any other entity.

WHEREFORE, S&T requests the Commission grant this motion for such other and further relief as the Commission deems just and proper.
