filed testimony. Failure to submit pre-filed testimony may result in the Commission restricting

the right to testify and present evidence at the evidentiary hearing.

6. Any person requiring special accommodations under the Americans with

Disabilities Act should notify the Commission at least 10 days before the scheduled hearing date.

7. Any party that fails to attend or participate in the hearing, or other stage of this

proceeding may be held in default pursuant to Kansas Administrative Procedure Act (KAPA),

K.S.A. 77-501 et seq.
