## ORDER GRANTING REQUEST FOR ADMINISTRATIVE NOTICE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On February 9, 2018, the Kansas Power Pool (KPP) filed its Application for Commission approval of a Transmission Rights Only (TRO) certificate in the retail service territory of Southern Pioneer Electric Company (Southern Pioneer).<sup>1</sup>
- 2. On September 6, 2018, Southern Pioneer filed a Request for Administrative Notice on behalf of itself, KPP, and Commission Staff.<sup>2</sup> The Request for Administrative Notice is unopposed.
- 3. The Commission may take official notice of its own records.<sup>3</sup> K.A.R. 82-1-230(h) provides "the presiding officer may take administrative notice of commission files and records in
