## ORDER TO SHOW CAUSE, DESIGNATING A PREHEARING OFFICER, AND SETTING A PREHEARING CONFERENCE

On February 7, 2014, Commission Staff moved the Commission to set this matter for hearing. The motion was served on the operator or operators, and no response was filed.

The Commission finds that the operator or operators in this docket should show cause why they are not responsible for plugging the wells on the captioned lease, as Staff has presented sufficient evidence to necessitate an evidentiary hearing.

Pursuant to K.S.A. 77-551(c), the Commission finds that a Prehearing Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b). The Commission also finds that an initial prehearing conference should be scheduled in this matter.

THEREFORE, THE COMMISSION ORDERS:

- B. A Prehearing Conference is scheduled for Tuesday, April 8, 2014. The Prehearing Conference shall begin at 1:30 pm, and shall end by 2:30 pm, at the Commission's offices, 130 S. Market, Room 2078, Wichita, Kansas 67202. Telephonic attendance may be

permitted by advance request. The Prehearing Conference will focus on the development of a

procedural schedule for this docket.

At the Prehearing Conference, parties shall be prepared to discuss deadlines for C.

filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission,

and any other issues that will promote the orderly and prompt resolution of this proceeding.

D. At the Prehearing Conference, without further notice, this proceeding may be

converted into a conference hearing or a summary proceeding for disposition of this matter as

provided by the Kansas Administrative Procedure Act ("KAPA"). Any party that fails to attend

or participate in the Prehearing Conference, hearing, or other stage of this proceeding shall be

held in default under the KAPA.

E. Pursuant to K.A.R. 82-3-228(d)(2), corporations must enter an appearance via an

attorney. If a corporation fails to enter an appearance via an attorney prior to the Prehearing

Conference, it shall be held in default under the KAPA.
