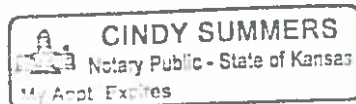

You, and each of you, are hereby notified that Griffin Management, LLC ("Griffin") has filed an application before the State Corporation Commission (the "Commission") requesting an order authorizing the drilling of the Terese 1H well (the "Well") as a horizontal wellbore. Griffin proposes to drill the Terese 1H horizontal wellbore upon its Terese Unit comprised of Section 8- T33S-Range 12W of the 6th PM, Barber County Kansas. The Terese 1H will be drilled to test the Viola Formation ("Producing Formation").
